ENVIRONMENT & CLIMATE CHANGE

Documation is committed to minimising the impact of its activities on the environment by;

- Minimising toxic emissions through the selection and use of its fleet and the source of its power requirement.
- Actively promoting recycling both internally and amongst its customers and suppliers.
- Sourcing and promoting a product range to minimise the environmental impact of both production and utilisation.
- Meeting or exceeding all the environmental legislation that relates to the Company
- Following the Waste Electronic and Electrical Equipment (WEEE) Directive for disposal of IT equipment.
- Using an accredited program to offset the greenhouse gas emissions generated by our activities that cannot be eliminated by change of working practice.

In 2021 we signed a pledge with TechNation to be **Net Zero by 2030**. We took base line measurements of our carbon footprint and since then have been reporting each year on our carbon emissions and offsetting what we can't reduce.

We use the **Gold Standard Marketplace** to purchase carbon credits which are retired in real-time in the Gold Standard impact registry for full traceability. Full details can be found on our website.

Our **supplier onboarding process** and ongoing reviews are designed to assess our new and existing suppliers' commitment to environmental, social and governance practices within their organisation to ensure they meet our minimum requirements for sustainability practices.

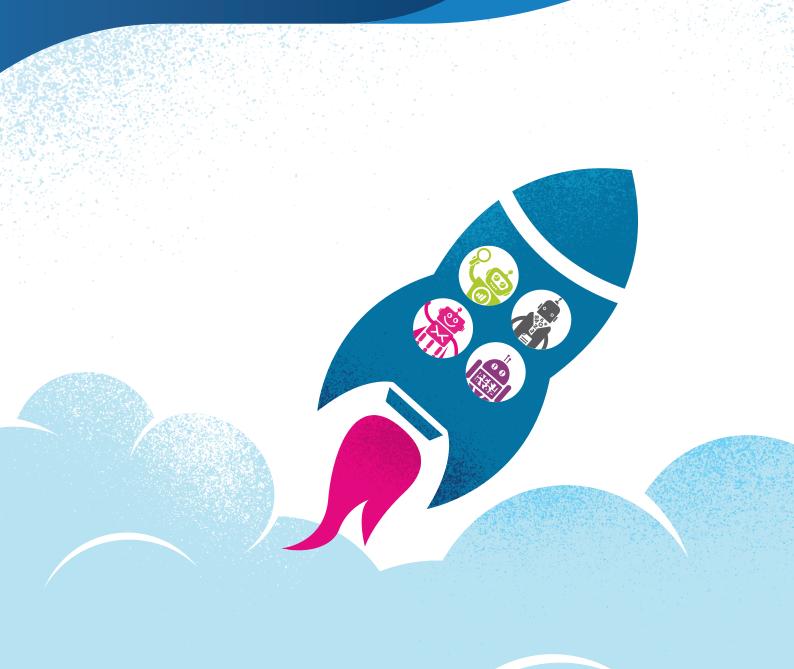
GOVERNANCE
